## **RULES AND REGULATIONS**

Your deponent is an applicant for a **STATIONARY PEDDLER'S LICENSE** from the Town of Islip and must adhere to by the following rules and regulations set forth by the Town of Islip.

1. Swear under oath to the truth of the statements contained in this affidavit.
2. Make this affidavit before an officer empowered to administer an oath; such as a notary public.
3. Has not been charged with, nor convicted of, any crime at any time prior to the making of this affidavit, except for the charges and convictions specified on this application.
4. Have the duty to notify the Town Clerk within twenty-four (24) hours of being charged with, or convicted of any crime.
5. Be aware that the business hours are from **8am-8pm only**.
6. The **HELPERS** may only be in the vehicle when the owner is present.
7. Shall not peddle the wares at or within **one thousand foot radius** of any municipal park, beach or other property or facility owned, leased or maintained by any governmental entity or public-benefit corporation unless specifically licensed by the Town Board or other governing body, to peddle food products by concession, lease or otherwise.
8. That it shall be unlawful to peddle within **two hundred (200) feet** of any property on which a church or school is located.
9. That no vehicle may **exceed twenty-five (25) feet in length**.
10. That no displays of merchandise or goods for sale other than in the vehicle used by the peddler. Displays of merchandise on the ground or on movable structures outside the peddler's vehicle are not permitted.
11. Only umbrellas which are mounted to the vehicle are permitted.
12. That signs used, including those which are painted on or attached to the peddler's vehicle, are subject to the regulations of the sign ordinance. (68-394).
13. Free standing signs are prohibited.
14. **Outdoor seating of any kind is not permitted.**
