Dear Boater,

Enclosed you will find the **2020 Boat Launching Permit Application**. To obtain a permit, please submit a completed application, the required documents listed below, and your payment. A separate permit is required for each boat/watercraft that is launched. The boat and trailer owner must be 18 years of age or older.

To save yourself \$30, we strongly suggest that you mail in the application packet with all of the required documents listed below. **Mail in applications will be \$70 and walk-in applications will be \$100.** When applying by mail, please submit photocopies only and be sure to **sign your application**.

In order to obtain your boat launching permit, please submit the following:

1. A completed 2020 Boat Launching Permit Application
2. A valid boat registration (Not applicable for Kayak/canoe use)
3. A valid trailer registration (If no trailer is used e.g. kayak/canoe valid car registration required)
4. One additional proof of residency in the same name and address of the boat owner. Choose from the following:
  - Driver's license
  - Property tax bill
  - Utility bills
5. Payment can be made by check or money order (*made payable to Town of Islip*) or by MasterCard or Visa. Resident Senior Citizens must present proof of age to receive the senior discount.

**RULES AND REGULATIONS:** The holder of this permit agrees to comply with the rules, regulations and requirements of the Town of Islip Ordinance Section 37 regulating parks, swimming pools, marinas, boats and waterways in the Town of Islip and any and all applicable requirements of the United States, New York State and the New York Board of Fire Underwriter (especially Town of Islip Ordinance 37-57). ~ Boat owner must be 18 years of age or older. ~ This permit is valid from March 1, 2020 to February 29, 2021. ~ Acceptance of this permit shall constitute an agreement that the permit holder will hold the Town of Islip and its authorized representatives completely blameless of any liability in connection with the operation, docking, tying or launching of his boat, or damage to such boat, trailer or any motor vehicle. The Town Board shall not be responsible for any injury, loss of life or damage to property (caused by storm, vandalism, theft, etc.) of the permit holder or passengers, guests, spectators or employees of permit holders in connection with the use of a marina. ~ Any holder of a ramp permit must attach the permit to the driver side tongue of the boat trailer. Any trailer parked without a permit is subject to a parking violation. If a boat trailer is not used in transporting the boat, the permit shall be placed on the driver side bumper of vehicle used to transport the boat. ~ Permits are not transferable.

I have read, understand and will abide by all the terms and conditions set forth below and hereby certify that all information furnished herein is true. I further understand that any intentional misrepresentation on this form constitutes an attempt to defraud the Town of Islip, and violators will be pursued with the appropriate legal actions. This application will not be accepted if it is not fully completed and signed.
