Dear Atlantique Boater:

Enclosed you will find the 2020 Atlantique Marina Permit Application. Applications will be processed **BY MAIL ONLY**. You will not be able to obtain this permit in person. The fee for the permit is \$35; our Senior Citizen resident fee is \$20. Payment may be made by check, money order, Master Card or Visa. Please make check or money order payable to the Town of Islip. **Permits are non-transferable**. If you change your boat during the season simply return the original decal along with your new boat registration and a new decal will be issued at no additional charge.

Please return the completed application and **four (4) proofs of residency**. **We will accept a combination of the following for proof of residency:**

- a copy of your boat registration or US Coast Guard Documentation **PLUS**
- a copy of your driver's license **PLUS**
- a copy of your property tax
- utility bills (i.e., water, cable, electric, telephone, cell phone)

**All proofs of residency and documentation must be in the same name and address.** Utility bills must be recently dated. Photocopies are accepted. If you have any questions, please contact the Atlantique Permit office at (631) 224-5404. Failure to supply sufficient documentation will delay the approval of your application. Any outstanding dock fees owed from the past season must be paid before we will process your application. **Mail all documents and payment to: Brookwood Hall, Attn: Atlantique Permit, 50 Irish Lane, East Islip, NY 11730.**
