- A survey map, or scaled drawing clearly indicating all areas to be cleared and/or graded, identifying all existing trees greater than ten (10) inches in caliper or as directed by the Commissioner of the Department of Planning and Development.
- Statement of Agent Authorization if a representative is acting on your behalf.
- Copies of permits required by other government agencies (N.Y.S. Department of Environmental Conservation).
- Fee of \$275.00.
- Certificate of Occupancy or a statement of use of existing structures on the subject property.
- Disclosure of any property covenants, deed restrictions, or special permit conditions which would affect or prohibit the development and clearing of the property.
- Short Environmental Assessment Form (SEAF).

Note: The omission of any of the required information listed above, or any additional information as requested by the Commissioner of the Department of Planning and Development, shall be considered grounds for the rejection of the application. If approved, permit will expire three (3) months from the date of issuance.

ALL PROPOSED SITE PLANS SHOULD INCLUDE THE FOLLOWING:

- Mark all trees that are **10 inches** in caliper or greater.
- Include all existing and proposed elevations on the property.
- Approximate quantity of proposed cut/fill (required if change is greater than forty cubic yards (40 yd³)).
