NOTICE IS HEREBY GIVEN that pursuant to the resolution duly adopted by the Board of Fire Commissioners of the Holbrook Fire District, in the Town of Islip, County of Suffolk, State of New York, at a regularly scheduled and publicly convened meeting of the Board on July 11, 2019 , a Special Election of the qualified voters of said Fire District, will be held at the Firehouse, 390 Terry Boulevard, Holbrook, New York, on August 27, 2019 beginning at 6:00.PM (Prevailing Time) and the polls shall remain open until 9:00 P.M. (Prevailing Time) or as much longer as may be necessary to enable the voters then present to cast their votes upon the following Proposition:

PROPOSITION

SHALL the resolution of the Board of Fire Commissioners of the Holbrook Fire District, in the Town of Islip, County of Suffolk, State of New York, entitled: **RESOLUTION OF THE HOLBROOK FIRE DISTRICT, IN THE TOWN OF ISLIP, SUFFOLK COUNTY, NEW YORK, ADOPTED JULY 11, 2019, AUTHORIZING THE INSTALLMENT PURCHASE OF A NEW AERIAL DEVICE AND FIREFIGHTING VEHICLE AND RELATED EMERGENCY SERVICE EQUIPMENT; STATING THE ESTIMATED MAXIMUM COST THEREOF, IS ONE MILLION SEVEN HUNDRED THOUSAND ( \$1,700,000.00) DOLLARS; PROVIDING FOR THE PAYMENT THEREOF BY THE EXECUTION OF AN INSTALLMENT PURCHASE AGREEMENT IN SAID APPROXIMATE AMOUNT AT THE PREVAILING RATE OF INTEREST AT THE TIME OF EXECUTION OF SAID INSTALLMENT PURCHASE AGREEMENT; STATING THAT IT HAS BEEN DETERMINED THAT SUCH PURCHASE IS AN UNLISTED ACTION PURSUANT TO THE STATE ENVIRONMENTAL QUALITY REVIEW ACT ("SEQRA") AND WILL NOT RESULT IN ANY ADVERSE ENVIRONMENTAL IMPACT, DETERMINING THAT THE PERIOD OF PROBABLE USEFULNESS OF THE VEHICLES TO BE PURCHASED IS TWENTY (20) YEARS; PROVIDING FOR THE LEVY OF TAXES TO BE COLLECTED TO PAY THE PRINCIPAL AND INTEREST ON SAID INSTALLMENT PURCHASE AGREEMENT; AND AUTHORIZING THE FIRE DISTRICT TO EXCEED THE ANNUAL SPENDING LIMITATION OF THE FIRE DISTRICT BY THE AMOUNT OF THE ANNUAL PAYMENTS OF PRINCIPAL AND INTEREST DUE UNDER THE INSTALLMENT PURCHASE AGREEMENT PURSUANT TO GENERAL MUNICIPAL LAW SECTION 176(18) be approved?**

NOTICE IS HEREBY GIVEN pursuant to the provisions of Town Law Section 175-a and Town Law Section 179 that a special public hearing will be held at the offices of the Holbrook Fire District and Firehouse, 390 Terry Boulevard Holbrook New York beginning at 7pm on August 14, 2019 and concluding at 9pm to afford members of the public to attend , participate, ask questions and set forth their opinions regarding the resolution and proposition to be voted upon as aforesaid. Officers and Members of the Holbrook Fire Department, Commissioners of the Holbrook Fire District and General Counsel to the Board of Fire Commissioners of the Holbrook Fire Department will be present at this hearing to publicly present the detailed information with respect to the long term planning and evaluation that has taken place with respect to the need for the proposed new firefighting vehicle for the benefit and protection of the residents of the Holbrook Fire District, to assist and enable the Officers and Members of the Holbrook Fire Department to better serve and protect the residents of the Holbrook Fire Department and better discharge their emergency and firefighting duties, the planning details, specifications of the proposed vehicle, the assessment and evaluation done by the Board of Fire Commissioners with respect to financial considerations and how best to acquire the vehicle in the most fiscally responsible manner and the details of the lease and installment purchase transaction proposed for that purpose. All are invited to attend and participate.
